SETTING THE HOLDING OF PUBLIC AUCTION FOR EXCLUSIVE FISHERY RIGHTS AND FIXING THE FLOOR PRICE FOR EACH ZONE, AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO CONTRACT WITH THE WINNING BIDDERS THEREOF

RESOLVED AS IT IS HEREBY RESOLVED, To: Set the holding of public auction for exclusive fishery right on January 25, 1999 at 3:00 o'clock p.m., in case of failure, the second and final bidding is hereby likewise set to be held ten (10) days thereafter;


RESOLVED FURTHER, To: Fix the floor price for each zone in the following manner:

Zone I	-	₱ 20,000.00
Zone II	-	50,000.00
Zone III	-	45,000.00
Zone IV	-	45,000.00
Zone V	-	50,000.00
Zone VI	-	40,000.00

RESOLVED FINALLY, To: Authorize the Municipal Mayor to enter into contractual agreement with the highest qualified bidder to whom the exclusive fishery rights have been granted by this Sanggunian; Provided: that this contract shall be in accordance with the conditions prescribed by the Department of Environment and Natural Resources;
