EARNESTLY REQUESTING THE HONORABLE PANFILO LACSON, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE AMOUNT OF TWO MILLION PESOS (P2M) FOR THE ASPHALTING OF FARM TO MARKET ROADS AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Section 1 of Article XII of the Constitution provides that the goals of the national economy are more equitable distribution of opportunities, income and wealth, a sustainable increase in the amount of goods and services produced by the nation for the benefit of the people and an expanding productivity as the key to raising the quality of life for all, especially the underprivileged;

"WHEREAS, the construction and subsequently the asphaltting of farm to market roads at the Municipality of Bulalacao, Province of Oriental Mindoro would lead to an easier shipment of various agricultural and marine products, enhance the value of these produce and open the floodgates for further development;

"WHEREAS, the realization of the abovementioned request will be of great importance in the implementation of programs that are geared towards the development and empowerment of our brothers and sisters in the countryside;

"WHEREAS, considering that the Municipality of Bulalacao, Province of Oriental Mindoro is a Pro-Poor Municipality pursuant to Executive Order No. 370, that financial assistance from the Honorable Lacson would make a lasting imprints among the people of this Municipality; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Panfilo Lacson, Senator, Republic of the Philippines to allocate the amount of Two Million Pesos (2M) for the asphaltting of farm to market roads at the Municipality of Bulalacao, Province of Oriental Mindoro;
