"RESOLUTION NO. 01-10-180

REQUESTING THE HONORABLE GEMMA G. SALAS, MUNICIPAL MAYOR TO ALLOCATE THE ADDITIONAL AMOUNT OF TWO HUNDREDD THOUSAND PESOS (₱ 200,000.00) UNDER THE 20% DEVELOPMENT FUND CY-2002 TO BE USED FOR THE COMPLETION OF TABOK FOOTBRIDGE SITUATED AT SITIO TABOK, BARANGAY POBLACION, THIS MUNICIPALITY

"WHEREAS, in response to the insistent public demand for a footbridge that would connect Sitio Tabok to the town proper, the Municipal Government of Bulalacao did it best to secure financial assistance from the higher government agencies and official that it got an initial amount from the former Congressman Punzalan;

"WHEREAS, the start of its construction two (2) years ago brought appreciation and happiness to the residents thereat but it was replaced by a gloomy sence of apprehension upon noticing that its construction was halted for unknown reasons;

"WHEREAS, upon coordination with the Department of Public Works and Highways, it was found out that the construction of the abovementioned footbridge was halted due to the insufficiency of funds brought about by some changes in the Program of Works;

"WHEREAS, it is further known that an additional amount of Two Hundred Thousand Pesos (₱ 200,000.00) is needed to complete the project and knowing the benefits that could be derived from it, the Municipal Mayor noted for her deep concern for the plight of her constituents is believed to prioritize this request; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Hon. Gemma G. Salas, Municipal Mayor to allocate the additional amount of Two Hundred Thousand Pesos (P 200,000.00) under the 20% Development Fund Cy-2002 to be used for the completion of Tabok Footbridge situated at Sitio Tabok, Barabgay Poblacion, this Municipality;
