EARNESTLY REQUESTING THE HONORABLE NOLI S. DE CASTRO, SENATOR, REPUBLIC OF THE PHILIPPINES TO PROVIDE OF ONE UNIT THREE CLASSROOM BUILDING INTENDED FOR BULALACAO NATIONAL HIGH SCHOOL EXTENSION, SITUATED AT BARANGAY SAN ROQUE, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Section 17, Article II of the Constitution provides that the State shall give priority to education, science and technology, arts, culture and sports to foster patriotism and nationalism, accelerate social progress and promote total human liberation and development;

"WHEREAS, there is only one secondary school in the Municipality of Bulalacao that the establishment of another one at Barangay San Roque would ease the difficulties of the students who need to travel everyday to a nearby high school at Manual, Municipality of Mansalay since the Bulalacao National High School is farther compared to the former;

"WHEREAS, the establishment of San Roque National High School would cater elementary graduate of that barangay and its adjacent sitios and barangays to the development and enhancement of education among the countryside which are always branded as the illiterate people; Now, therefore, be it

Noli S. de Castro, Senator, Republic of the Philippines to provide of one unit three classroom building intended for Bulalacao National High School Extension, situated at Barangay San Roque, Municipality of Bulalacao, Province of Oriental Mindoro;
