EARNESTLY REQUESTING DIRECTOR ROSA F. MACAS, BUREAU OF FISHERIES AND AQUATIC RESOURCES, REGION IV TO GRANT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO WITH 50 UNITS OF GILLNET, 50 UNITS OF DEEPSQUID GIGGERS AND 50 UNITS OF SHALLOW SQUID GIGGERS TO BE USED BY THE MARGINAL FARMERS OF THE TOWN

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is composed of eight (8) coastal barangays whose primary source of income of the residents is fishing;

"WHEREAS, in order to increase marine production, there is a need to provide the fishermen with technical knowledge coupled with modern fishing facilities and paraphernalia that would definitely benefit them socially and economically;

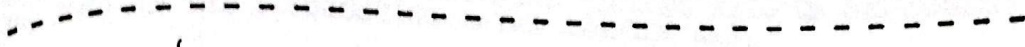
