" RESOLUTION NO. 00-09-141

RESOLUTION COMMENDING THE PNP FORCES OF BULALACAO STATION WHO FOUGHT IN AN AMBUSH CONDUCTED BY SOME ELEMENTS OF THE NEW PEOPLES ARMY (NPA) LAST SEPTEMBER 10, 2000 AT SITIO CABILLAN, BARANGAY NASUCOB, THIS MUNICIPALITY FOR THEIR PATRIOTIC SENSE AND DEVOTION TO DUTY

"WHEREAS, the nation has been plunged for a few decades into a necessary violence by the forcible attempts of rebellious armed groups such as the New Peoples Army (NPA) to grab political power from the duly constituted authorities;

"WHEREAS, on that black Sunday of September 10, 2000, the people of Bulalacao were alarmed by the news that the police officers belonging to Bulalacao Station were indiscriminately ambushed by the alleged members of the CPP/NPA at Sitio Cabillan, Barangay Nasucob, this Municipality;

"WHEREAS, three PNP personnels have been injured in the fight that raged for about 15 to 20 minutes exchange of fire fighting;

"WHEREAS, despite the danger of losing their lives, the police officers who were caught in that incidence gallantly stood their grounds;

"WHEREAS, the rebels have been repulsed by the police forces who have shown bravery and full commitment to our democratic principles and who unwaveringly risk their lives to maintain peace and the rule of the law;

"WHEREAS, the Municipal Government of Bulalacao recognizes the heroism of our police officers and that the conduct shown by them is certainly commendable; that their moral courage, dedication to duty and patriotism have lived up to the prestige and stature of a professional police force worthy of emulation; Now, therefore, be it









