RESOLUTION NO. 01-08-107

**REQUESTING THE HONORABLE BARTOLOME L. MARASIGAN, GOVERNOR, PROVINCE OF ORIENTAL MINDORO TO RETAIN THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) SUB-OFFICE II AT ROXAS, ORIENTAL MINDORO**

*“WHEREAS*, the powers of construction and maintenance of provincial roads and bridges, irrigation systems, mini hydro-electric projects for local purposes, estrums-municipal water works, drainage, sewerage, flood controls, fish ports, jails, facilities for industrial resource and development including transfer of appropriate technology among others have been devolved to the Local Government Units;

*“WHEREAS*, such transfer of certain powers over the delivery of infrastructure services and facilities to LGU's affects the mandate of the Department of Public Works and Highways to ensure the safety of all infrastructure facilities and to secure for all public works and highways the highest efficiency and the most appropriate quality in construction and provides supervision over all public works construction and ensure that actual construction is done in accordance with the approved government plan and specifications; as provided for under Book IV of the Revised Administrative Code;

*“WHEREAS*, it is then provided that though the power and the authority to do all that insofar has public works, infrastructure and projects are concerned belonged to the LGU as mentioned above; the DPWH however is still mandated to assist the Local Governments in determining the most suitable entity to undertake the actual construction of public works projects;

*“WHEREAS*, based on the clamor of the Local Officials of the 2nd Congressional District of Oriental Mindoro a Sub-District Office of the DPWH was established at Roxas, Oriental Mindoro to enliven the task considered above;


"WHEREAS, it was learned through the grape vine that DPWH Sub-Office at Roxas would be transferred to Pinamalayan if not totally abolished brought disappointment to the interior barangays and far-flung municipalities of the Second District of Oriental Mindoro for they feared that the recent progress that has been achieved might be aborted fearing that the experience of being neglected for a very long time will be a recurrent possibility;

"WHEREAS, considering the benefits of having accessible DPWH Office that should respond in a short notice, the Municipality of Bulalacao strongly maintains that such office be maintained at its present location; Now, therefore, be it


