"WHEREAS, the primary objective of the Unit III Meet is to select a pool of skilled, talented and potential athletes who will represent Unit III to the Provincial Meet;






RESOLVED FURTHER; To: Let copy of this resolution be furnished the Bulalacao National High School for their information, guidance and ready reference;
