RESOLUTION NO. 03-02-032

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2003 OF BARANGAY SAN FRANCISCO, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF THREE HUNDRED NINETY FOUR THOUSAND THREE HUNDRED NINETY TWO PESOS (PHP394,392.00) PASSED UNDER SANGGUNIANG BARANGAY RESOLUTION NO. 001-2003 AND APPROPRIATION ORDINANCE NO. 001 CY 2003, DATED FEBRUARY 1,2003

"WHEREAS, Section 57 and Section 447 par (ii) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, the Sangguniang Barangay of San Francisco, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY2003 showing therein the sources of income and barangay expenditures starting from January 1,2003 up to December 31,2003;

"WHEREAS, the Barangay Fund Annual Budget for FY2003 of Barangay San Francisco was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on February 24,2002 and was found to be consistent and in accordance with the priority development projects of the barangay with the advice that all projects funded under the 20% Development Fund be implemented and should not be realigned to any other projects;

"WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing COA rules and regulations; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Approve the Barangay Fund Annual Budget for FY 2003 of Barangay San Francisco, Bulalacao, Oriental Mindoro appropriating the amount of Three Hundred Ninety Four Thousand Three Hundred Ninety Two Pesos (Php394,392.00) passed under Sangguniang Barangay Resolution No. 001-2003 and Appropriation Ordinance No. 001 CY 2003, dated February 1, 2003;
