RESOLUTION NO. 03-01-015

EARNESTLY REQUESTING THE REGIONAL DIRECTOR, BUREAU OF FISHERIES AND AQUATIC RESOURCES, REGION IV TO DEVOLVE TO THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO THE PLANNING AND MANAGEMENT OF THE 96 HECTARES OF FISHPOND LEASE AGREEMENT SITUATED AT SITIO TABOK, BARANGAY POBLACION, BULALACAO, THIS PROVINCE

"WHEREAS, the 96 hectares of the Fishpond Lease Agreement (FLA) situated at Sitio Tabok, Barangay Poblacion, this Municipality which was previously granted to Mr. Arnulfo Sison was cancelled by the Bureau of Fisheries and Aquatic Resources (BFAR) due to his failure to develop the area;

"WHEREAS, since the cancellation of the abovementioned Fishpond Lease Agreement, encroachment have been made by some people without securing any permit from the Municipal Government of Bulalacao or from BFAR; this situation leads to misunderstanding and dispute among the occupants and even brought problems to the local Government Unit which would not immediately act on it due to the respect for the concerned higher government agencies who still have direct supervision on that Fishpond Lease Agreement;


"WHEREAS, the Municipal Government of Bulalacao is in the process of formulating programs and policies particularly mangrove reforestation for that cancelled Fishpond Lease Agreement which would be implemented soon if all the rights, management and supervision be granted by BFAR to the former;


"WHEREAS, to avoid more serious conflicts in the future, this Sanggunian believes that all applications for the FLA particularly that of Mr. Leonardo Rivera and others be rejected until a particular agency be pointed-out to have all the rights and control of the mentioned Fishpond Lease Agreement, Now, therefore, be it


