**EARNESTLY REQUESTING THE SECRETARY, DEPARTMENT OF EDUCATION TO FACILITATE THE SEPARATION AND CONVERSION OF BULALACAO NATIONAL HIGH SCHOOL MAUJAO ANNEX SITUATED AT BARANGAY MAUJAO FROM THE BULALACAO NATIONAL HIGH SCHOOL MAIN BOTH ARE SITUATED AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**"WHEREAS,** it is a Constitutional mandate that the State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all. It shall establish, maintain and support a complete, adequate and integrated system of education relevant to the needs of the people and society;

**"WHEREAS,** in conformity with the abovementioned constitutional mandate, the Municipal Government of Bulalacao, Oriental Mindoro facilitated the establishment of Bulalacao National High School Maujao Annex at Barangay Maujao in 2001 to cater elementary graduates coming from five (5) adjacent barangays;

**"WHEREAS,** the establishment and operation of the abovementioned secondary school in 2001 up to the present by the Municipal Government of Bulalacao redound to the social and economic benefits of both the parents and students alike that give this local government unit the courage to pursue even faced with financial difficulties and sacrifice some of its developmental projects;

"WHEREAS, to ease the financial constraints of this Pro-Poor Municipality, there is a need to separate and convert the Bulalacao National High School Maujao Annex from the Bulalacao National High School Main so as the teachers assigned thereat be nationally absorbs and funded as defined by a particular law providing that a school established and operated by the local government unit be automatically absorb by the national agency after its five (5) years of operation; Now, therefore, be it
