RESOLUTION NO. 06-05-048

URGING THE MUNICIPAL MAYOR TO STRICTLY IMPLEMENT ALL APPLICABLE ORDINANCES, RULES AND REGULATIONS THAT PROHIBIT THE OPERATION AND MAINTENANCE OF LOTENG AT THE MUNICIPALITY OF BULALACAO

"WHEREAS, this Sangguniang Bayan is empowered and mandated to enact ordinances and approve resolutions empowered to declare, to prevent, or abate any nuisance under Section 447 par. 4 sub. par. 1 of Republic Act 7160;

"WHEREAS, this Sanggunian on its credit passed and approved voluminous resolutions and ordinances in order to promote and implement the basic policies and laws under Sec. 17 of the same Law. This Sanggunian is filled with utter disgust and asking itself what has gone wrong and why the passed and approved ordinances remain to be dormant;

"WHEREAS, it is disgraceful to get the information that "loteng" which is similar to "jueteng" has now time and again reemerged in our municipality;

"WHEREAS, this kind of activity is considered by this august Body to be an economic menace as the continued operation would only result to financial drain of our remaining financial resource as people rely most on luck rather than on work without knowing that their little money saved were being siphoned by the greedy operators;

"WHEREAS, the Government in view of the moral and legal malfeasance and misfeasance that those allegedly operate "jueteng" committed in this municipality must be brought accordingly into the folds of the law;

"WHEREAS, under Section 444 of the same Law, empowers the Municipal Mayor as the Local Chief Executive to enforce all laws and ordinances relative to the governance of the municipality on the exercise of its corporate power provided for under Section 22 of the Code, implement all approve policies, programs, projects, services and activities of the municipality; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Urge the Municipal Mayor to strictly implement all the applicable ordinances, rules and regulations that prohibit the operation and maintenance of loteng at the Municipality of Bulalacao;


