SPECIAL ORDINANCE NO. 08-09-98

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A NEGOTIATED CONTRACT WITH TABOK SMALL FISHPOND OPERATORS REPRESENTED BY ITS PRESIDENT, PATERNO CANDELARIO GRANTING THE LATTER THE EXCLUSIVE FISHERY RIGHTS IN ZONE IV IN VIEW OF THE TWO (2) CONSECUTIVE FAILED BIDDINGS THEREOF






SEC. 2. This Special Ordinance shall take effect immediately.
