**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro.


**SECTION 1.** The cellphone load of the following qualified municipal officials and employees are hereby increased in the following manner; to wit:




SEC. 2. This Special Ordinance shall take effect subject to the availability of funds.




