
"WHEREAS, on September 18, 2020, DENR-MIMAROPA Region sent a letter stating that the Province of Oriental Mindoro was covered by the Forest Land Boundary Delineation (FLBD) as mandated under DAO 24 series of 2008 which aimed to delineate final ground boundaries between A&D and the Forestland, its final FLBD proposal was endorsed already to Congress to which the deliberation and approval was still in pending status;




