EARNESTLY REQUESTING THE COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICE, SAN MARIANO, ROXAS, ORIENTAL MINDORO TO CONDUCT RECONNAISSANCE SURVEY OF ALL THE WATERSHED AREAS IN THE MUNICIPALITY OF BULALACAO, THIS PROVINCE

"WHEREAS, recognizing that water in itself is life for all living things, the present situation where the crisis for water grinds the life of every Filipino and even threatens the survival of humanity, commands and dictates us to protect our every remaining water sheds which are being endangered and systematically abused by ignorant, irresponsible and unlawful perpetrators, all in the travesty of justice concerning the implementation of environmental laws, rules and regulations, the official motion made by the United Nation to think globally and act locally boost be promoted and this Municipality is marshaling all its powers to act on that principle hence, it took the cudgel of taking the initiative in identifying the sources of potable waters in the entire community;

"WHEREAS, a positive action is critically needed for now thus; after identifying the sources it was agreed that a survey along the areas be made and further declared the two (2) hectares perimeter surrounding every spring as Protected Watershed Area,
