AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE ERNILO C. VILLAS TO ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO WITH THE DEPARTMENT OF AGRICULTURE AS REPRESENTED BY ITS REGIONAL DIRECTOR IN THE RELEASE OF FUND IN THE AMOUNT OF THREE MILLION PESOS (PHP3,000,000.00) FOR THE PURCHASE OF FOLIAR AND ORGANIC FERTILIZERS

WHEREAS, the Municipality of Bulalacao is the recipient of the financial assistance from the Department of Agriculture, thru its Regional Field Unit IV, Diliman, Quezon City in the amount of Three Million Pesos (PHP3,000,000.00) for the purchase of foliar fertilizer intended for the marginalized farmers in this Municipality,

WHEREAS, under Republic Act 7160, otherwise known as the Local Government Code of 1991, empowers the Municipal Mayor to enter into contracts and agreements by and between for and in behalf of the municipality for the benefit of public welfare;

WHEREAS, the Memorandum of Agreement explicitly stipulates the responsibilities of both parties in connection with the implementation of the said program for the benefit of the farmers of the municipality. Now therefore, be it . . .

RESOLVED AS IT IS HEREBY RESOLVED, To: Authorize the Municipal Mayor, Honorable Ernillo C. Villas to enter into a Memorandum of Agreement for and in behalf of the Municipality of Bulalacao, Province of Oriental Mindoro with the Department of Agriculture as represented by its Regional Director in the release of fund in the amount of Three Million Pesos (PHP3,000,000.00) for the purchase of Foliar and Organic Fertilizers;
