AUTHORIZING THE MUNICIPAL MAYOR TO REPRESENT THE MUNICIPALITY OF BULALACAO IN THE APPLICATION FOR DEPARTMENT OF LAND REFORM (DLR) CLEARANCE RELATIVE TO THE DEED OF DONATION EXECUTED BY THE LEGITIMATE HEIRS OF THE LATE CARMELITA YANG REPRESENTED BY ENGR. RODOLFO V. DAYANGHIRANG IN FAVOR OF THE MUNICIPALITY OF BULALACAO INTENDED FOR GAWAD KALINGA HOUSING PROJECT AT SITIO NAPISIAN, BARANGAY CAMBUNANG, BULALACAO, ORIENTAL MINDORO

"WHEREAS, a parcel of land situated at Barangay Cambunang, Bulalacao, Oriental Mindoro containing an area of Thirty Thousand Three Hundred Ninety Nine (30,399) square meters, belonging to the late Carmelita Yang was donated by her legitimate heirs to the Municipal Government of Bulalacao, Oriental Mindoro, for the sole purpose of being a site for a housing program in that barangay under the Gawad Kalinga Luzon Housing Project in partnership with the DSWD, ABS/CBN, Ateneo de Manila University, and Local Government Unit of Bulalacao, Oriental Mindoro;

"WHEREAS, there are still some procedures that should be undertaken to finalized the subsequent transfer of Title in favor of the donee;




