EARNESTLY REQUESTING HER EXCELLENCY GLORIA MACAPAGAL ARROYO, PRESIDENT, REPUBLIC OF THE PHILIPPINES TO ALLOCATE FIVE HUNDRED THOUSAND PESOS (Php500,000.00) WORTH OF MEDICINES FOR THE INDIGENT RESIDENTS OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, it is a Constitutional mandate that the State shall protect and promote the right to health of the people and instill health consciousness among them;

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is a Pro-Poor Municipality pursuant to Executive Order No. 370 and whose population is approximately composed of 20% Hanunuo Mangyan who because of poverty are deprived of their basic right to health;

"WHEREAS, the Municipal Health Office which is manned by one (1) physician, one nurse and a few midwives could not effectively render health services to the ailing patients if it were not coupled with the availability of medicines;

"WHEREAS, the distribution of medicines for the indigents is a consolation to those patients who could not afford to buy from the drugstores and it is believed that Her Excellencys' prime concern is to achieve the good health of the citizenry; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request Her Excellency Gloria Macapagal Arroyo, President, Republic of the Philippines to allocate Five Hundred Thousand Pesos (Php500,000.00) worth of medicines for the indigent residents of the Municipality of Bulalacao, Province of Oriental Mindoro;
