**"WHEREAS,** Bulalacao is well-nigh to being an agro-eco-tourism destination of the Province of Oriental Mindoro, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

**"WHEREAS,** rice pavement drying is essential to the rice industry of this municipality as it can be used in the post-harvesting for large-scale drying wherein grains are laid on pavements specifically made for drying because it is important to dry rice grain as soon as possible because delays or ineffective drying will reduce grain quality and may result to grain discoloration, development of molds, and increase the likelihood of pest's attack;


**"WHEREAS,** for this reason, the Local Government of Bulalacao understands the needs and circumstances of its farmers in providing best agricultural products without compromising their own income, thus, it would need the above-titled request to be established to fully support the farmers; Now, therefore, be it...




