### RESOLUTION NO. 09-10-139

EARNESTLY REQUESTING ENGR. EFREN S. PADILLA, DISTRICT ENGINEER, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, ROXAS, ORIENTAL MINDORO TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF TWO (2) CLASSROOM BUILDING FOR CABUGAO ELEMENTARY SCHOOL SITUATED IN BARANGAY CABUGAO, BULALACAO, ORIENTAL MINDORO

**"WHEREAS,** it is a Constitutional mandate that the State shall assign the highest budgetary priority to education and that quality and basic education be made available to all;

**"WHEREAS,** Cabugao Elementary School in Barangay Cabugao, Municipality of Bulalacao, Province of Oriental Mindoro is in dire need of additional classroom buildings to house and accommodate the increasing enrollees thereat approximately reaching to 20% each year resulting to crowding of pupils up to 100 per room;

**"WHEREAS,** it is likewise observed that the old classrooms were already dilapidated which pose danger to lives and properties particularly during the onslaught of bad weather conditions;

**"WHEREAS,** quality education ensures all possible conditions for the fullest development of the pupils given the right opportunities and enough facilities to achieve educational goals; Now, therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Earnestly request Engr. Efron S. Padilla, District Engineer, Department of Public Works and Highways, Roxas, Oriental Mindoro to allocate the necessary funds for the construction of two (2) classroom buildings for Cabugao Elementary School situated in Barangay Cabugao, Bulalacao, Oriental Mindoro;
