### RESOLUTION NO.12-10-087

**A RESOLUTION STRONGLY SUPPORTING THE PASSAGE OF SENATE BILL NO. 2987 INTO A LAW FILED BY SENATOR AQUILINO "KOKO" L. PIMENTEL III INCREASING THE SHARE OF LOCAL GOVERNMENT UNITS FROM 40% OF THE NATIONAL INTERNAL REVENUE TAXES TO 50% SHARE IN ALL NATIONAL TAXES**

**"WHEREAS**, Senator Aquilino "Koko" L. Pimentel III filed last October 10, 2011 Senate Bill No. 2987 entitled; "An Act increasing the Share of Local Government Units from 40% of the National Internal Revenue Taxes to 50% share in all national taxes, to include all the national taxes collected by the Bureau of Internal Revenue, Bureau of Customs, Philippine Ports Authority, Department of Environment and Natural Resources, the Department of Foreign Affairs and such other government agencies deputized by the Bureau of Internal Revenue to collect national taxes amending for this purpose Section 284 of Republic Act 7160, otherwise known as the Local Government Code of 1991;

**"WHEREAS**, this Bill seeks to amend Section 284 of R.A. 7160 otherwise known as the "Local Government Code of 1991" on allotment of Internal Revenue Taxes hence, consistent with the promotion and enhancement of local fiscal autonomy and will translate into more dynamic Local Government Units especially in the area of development of local communities;

**"WHEREAS**, as provided under explanatory notes, the Internal Revenue Allotment (IRA) of local governments has been the lifeblood of many of them as far as operation at the local level is concerned. The IRA share as contemplated in the proposed amendments, is enhanced and broadened to include sharing in national taxes;

"WHEREAS, the Bill, once approved by duly constituted authority, local government units (LGU'S) will surely enjoy a true, genuine and meaningful local autonomy to enable them to attain their fullest development as self-reliant communities and make them more effective partners in the attainment of national goals;

"WHEREAS, the promotion of general welfare of the respective constituents of all local government units in the Philippines demands that it is of high time that all concern must be one and united to support this noble intention in order to provide the best public service that our fellowmen deserve;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED TO: PASS AND APPROVE A RESOLUTION STRONGLY SUPPORTING THE PASSAGE OF SENATE BILL NO. 2987 INTO A LAW FILED BY SENATOR AQUILINO "KOKO" L. PIMENTEL III INCREASING THE SHARE OF LOCAL GOVERNMENT UNITS FROM 40% OF THE NATIONAL INTERNAL REVENUE TAXES TO 50% SHARE IN ALL NATIONAL TAXES
