RESOLUTION NO. 08-02-023

DECLARING A MORATORIUM ON MASSIVE PRODUCTION AND EXPORTATION OF WOOD CHARCOAL OUTSIDE THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO, EFFECTIVE MARCH 1, 2008 UNTIL THE APPROVAL OF THE PROPOSED ESTABLISHMENT OF ULINGAN CENTERS IN THIS MUNICIPALITY

"WHEREAS, there are several clamors from among different sectors calling for the immediate banning of massive production and exportation of wood charcoals explaining the ill-effects of this activity against society and Mother Nature;

"WHEREAS, balancing the ecological arguments vis-à-vis the need to provide source of income to the inhabitants, the establishment of "ulingan centers" was conceived as an alternative;

"WHEREAS, this sanggunian intends to have a thorough and comprehensive study of the issue as it tries to appreciate and see both sides of the coin; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED, To: Declare a moratorium on massive production and; exportation of wood charcoal outside the Municipality of Bulalacao, Province of Oriental Mindoro, effective March 1, 2008 until the approval of the proposed establishment of Ulingan Centers in this Municipality;

RESOLVED FURTHER, To advise all shippers, traders, businessmen and producers engaged in this trade to ship out their goods until February 29, 2008;


