RESOLUTION NO. 09-04-049-A

ADOPTING REPUBLIC ACT NO. 9296 OTHERWISE KNOWN AS THE MEAT INSPECTION CODE OF THE PHILIPPINES FOR THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, it is the declared policy of the State to promulgate specific policies and procedures governing the flow of food animals, meat and meat products through the various stages of marketing and the proper preservation and inspection of such products;


“WHEREAS, there is likewise a policy to extend support local government units in their endeavor to be self-reliant and to continue exercising the powers and discharging the duties and functions currently vested upon them;

“WHEREAS, in order to secure food security and provide safety and quality standards for consumer products relative to the livestock and poultry to assure the production of the public against unreasonable risks of injury and hazards to health; it is necessary and of vital importance to adopt RA No. 9296 and its Implementing Rules and Regulations in order to ensure protection of human health against direct and indirect hazards of consumers; Now, therefore, be it


