RESOLUTION NO. 09-04-018

EARNESTLY REQUESTING THE HONORABLE ANGELO T. REYES, SECRETARY, DEPARTMENT OF ENERGY TO ALLOCATE THE AMOUNT OF THIRTY MILLION PESOS (PHP30M) TO BE USED FOR THE CONSTRUCTION/INSTALLATION OF ELECTRIC MAIN IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, in order to speed-up the face of development in the countryside, the National Government has been more active in the electrification project in the rural areas through various means;

"WHEREAS, power generation means generating more opportunities socially and economically and to cope up with the challenges of the modern world wherein electricity is of greater importance;

"WHEREAS, it has long been the clamor of people living in the remotest barangays of the Municipality of Bulalacao, Province of Oriental Mindoro to avail the services of the power generating facilities so that economic progress may be hastened and in the process be freed from isolation due to the absence of electricity that serves as barrier;

"WHEREAS, such clamor is always heard from them particularly from the following barangays that electrification project be finally implemented so that residents thereat would see the brighter life for their brighten future; to wit:


- i. Barangay San Francisco - Barangay San Isidro -

- iii. Barangay Balatasan - to Barangay Maasin - 5 M

Now, therefore, be it


