RESOLUTION NO. 10-03-037

REQUESTING MR. ALBERTO SUANSING, CHAIRMAN, LAND TRANSPORTATION AND FRANCHISING REGULATORY BOARD (LTFRB) TO DETERMINE THE LEGAL, MANDATORY AND FIXED FARE FOR BULALACAO-SAN JOSE ROUTE IN THE SOUTHERN MINDORO COASTAL ROAD

"WHEREAS, the distance between the Municipalities of Bulalacao, Oriental Mindoro and San Jose Occidental Mindoro measures 52 kilometers;

"WHEREAS, the rate of fare was pegged at Php250.00 per passengers by the operators plying the said route; though exorbitant, excessive and unjust was accepted by the riding public having no choice or alternative;

"WHEREAS, the reason presented that the road was not yet opened for travel; classified as all weather road, and travelling therein was hard and sometimes dangerous; however with the concreting of the said road, all the abovementioned grounds are now considered non-applicable and therefore the prevailing rates of fare promulgated by the LTFRB must be the guiding rates of fares that should be collected from the riding public; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request Mr. Alberto Suansing, Chairman, Land Transportation and Franchising Regulatory Board (LTFRB) to determine the legal, mandatory and fixed fare for Bulalacao-San Jose route in the Southern Mindoro Coastal Road;

RESOLVED FURTHER, To request the LTFRB that copies of the approved rates of fares for the route be furnished the transport operators accredited and given "line" to operate in that herein mentioned route;

RESOLVED FURTHERMORE, To furnish Land Transportation Office (LTO), Calapan City with copy of this Resolution for their information and reference;
