**RESOLUTION REQUESTING FACEBOOK PHILIPPINES TO FACILITATE
CENSORSHIP ON THE MALICIOUS POSTS AND COMMENTS BEING
SHOWN IN FACEBOOK APPLICATION**

“WHEREAS, the pervasive use of social media in the country massively affected the manner by which Filipinos interact and communicate; while the Philippines is not an information based society, it is very much a networked culture that the development in Information and Communications Technology (ICT) derelict the refrainment and verification of data sharing to different social media platforms; among these is Facebook which is the easiest and more convenient application to use for most of the Filipinos;

“WHEREAS, the Philippines has no specific and direct policy dealing with the censorship of posts and comments in different social media, however, there are several laws including jurisprudence that deal with privacy in general and in relation to social media; scope of these can be found in the Constitution, Revised Penal Code, Rules of Court and Civil Code;

“WHEREAS, enclosed to Article 355 of the Revised Penal Code, the crime of libel is committed when a person makes, against another, a public and malicious imputation of a crime, or of a vice or defect, real or imaginary, or any act, omission, condition, status or circumstance tending to cause the dishonor, discredit or contempt of a natural or juridical person, or to blacken the memory of one who is dead;

“WHEREAS, the dissemination of malicious opinions, hate speeches and unverified information through social media platforms have been escalated in the municipality of Bulalacao which affects certain residents and its local government unit most especially the honorable officials;
