RESOLUTION NO. 21-06-194

RESOLUTION REQUESTING THE PROVINCIAL VETERINARY OFFICE OF ORIENTAL MINDORO TO CONDUCT MEDICAL MISSION THAT WILL CATER ASSESSMENT OF POSSIBLE DISEASES AND PROVISION OF VACCINATION AND VITAMINS INTENDED FOR THE SMALL AND LARGE ANIMALS IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, Section 17 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities necessary, appropriate, or incidental to efficient and effective provision of basic services and facilities such as agricultural extension and on-site research services and facilities which include the prevention and control of plant and animal pest and diseases;

“WHEREAS, Section 1 of Republic Act No. 8485 otherwise known as the Animal Welfare Act of 1998 intended to protect and promote the welfare of all animals in the Philippines by supervising and regulating the establishment and operations of all facilities utilized for breeding, maintaining, keeping, treating or training of all animals either as objects of trade or as household pets including birds;

“WHEREAS, Bulalacao is a 3rd class municipality located at the southernmost tip of the Province of Oriental Mindoro, it used to be known figure as supplier of large cattle and other livestock animals in the province and nearby provinces, and just like other places most of the households here own pets like dogs and cats;

WHEREAS, recently, there have been reports that most of the pets in this municipality particularly dogs and other animals like cows are having flu and unknown diseases that caused the owners worrisome not only in the condition of the animals but to their health as well because they are unsure that it can be a communicable disease which can transmit to people;

"WHEREAS, the Local Government Unit of Bulalacao protects and upkeeps the health and welfare of both people and animals, thus having limited resources to veterinary practice and medicine it would need help and support to cure the ailing animal and assess whether there is a widespread epidemic on the animals of this municipality; Now, therefore, be it...

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Provincial Veterinary Office of Oriental Mindoro to conduct medical mission that will cater assessment of possible disease and provision of vaccination and vitamins intended for small and large animals in the Municipality of Bulalacao, Province of Oriental Mindoro;






