RESOLUTION NO. 21-06-191

EARNESTLY REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT THRU SECRETARY WENDEL AVISADO TO ALLOCATE THE AMOUNT OF ONE HUNDRED THIRTY FIVE MILLION PESOS (PhP135,000,000.00) TO BE USED FOR THE CONSTRUCTION AND MAINTENANCE OF FLOOD MITIGATION STRUCTURE AND DRAINAGE SYSTEMS, AND THE CONSTRUCTION OF BULALACAO SEAWALL REVETMENT IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions, local government units shall promote health and safety;

“WHEREAS, the Department of Budget and Management (DBM) is responsible for the formulation and implementation of the National Budget, and the efficient and sound utilization of government funds and revenues to achieve the country's development goals;

“WHEREAS, Bulalacao, a third class municipality located at the southernmost tip of Oriental Mindoro, has 15 barangays 8 of which are coastal barangays, and has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

“WHEREAS, because of its location and climate type, Bulalacao is at high risk of weather disturbances and typhoons which causes flooding, storm surges and other damages that affects both agricultural and aquaculture industries, and the safety of the people;

“WHEREAS, it is imperative to construct drainage system and flood control facilities to ensure public welfare and safety and to mitigate the effects of typhoons and floods, and also it is an advantage to construct seawall/revetment that will protect inland area against wave action and prevent coastal erosion and it is a massive structure that will protect people from storm surges;

“WHEREAS, the provision of flood mitigation structure, drainage systems and seawall/revetment in this municipality will support counter insurgency in conveying awareness to people showing that the Government is focused in giving welfare and development in the countryside, and providing them infrastructural facilities that shall be beneficial to the community at all times; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Department of Budget and Management thru Secretary Wendel Avisado to allocate the amount of one hundred thirty five million pesos (PhP135,000,000.00) to be used for the construction and maintenance of flood mitigation structure, and the construction of Bulalacao Seawall Revetment in the Municipality of Bulalacao, Oriental Mindoro.
