RESOLUTION REQUESTING CONGRESSMAN ALFONSO V. UMALI, JR., 2ND DISTRICT REPRESENTATIVE, PROVINCE OF ORIENTAL MINDORO TO FACILITATE THE APPROPRIATION OR ALLOCATION OF TEN MILLION PESOS (PHP10,000,000.00) FOR THE CONSTRUCTION OF FLOOD CONTROL MITIGATION PROJECT ALONG THE KABURAYAN RIVER SPECIFICALLY FRONTING TABUK ISLAND IN POBLACION, BULALACAO, ORIENTAL MINDORO

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

WHEREAS, Bulalacao, a third class municipality located at the southernmost tip of Oriental Mindoro, has 15 barangays 8 of which are coastal barangays, and has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

WHEREAS, because of its location and climate type, Bulalacao is at high risk of weather disturbances and typhoons which causes flooding, storm surges and other damages that affects both agricultural and aquaculture industries, and the safety of the people;


