**RESOLUTION REQUESTING THE DEPARTMENT OF TOURISM (DOT)  
THRU SECRETARY BERNADETTE ROMULO-PUYAT TO GRANT FUNDS  
FOR THE CONSTRUCTION OF WATER SEWAGE TREATMENT FACILITY  
IN BARANGAY POBLACION, MUNICIPALITY OF BULALACAO,  
PROVINCE OF ORIENTAL MINDORO**

**"WHEREAS**, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

**"WHEREAS**, the Department of Tourism (DOT) is the executive department of the Philippine Government responsible for the regulation of the Philippine tourism industry and the promotion of the Philippines as a tourist destination;

**"WHEREAS**, Bulalacao is well-nigh to being an agro-eco-tourism destination of the Province of Oriental Mindoro, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;


**"WHEREAS**, in terms of population density, Poblacion is one of the populous barangay in Bulalacao which corollary to huge waste pollution especially liquid waste that hardly affects it marine and coastal area, thus it is important to have water sewage treatment facilities that can manage the industrial and other wastewater, and remove pollutants and produce an effluent that can be discharged to use for the environment;


"WHEREAS, the provision of water sewage treatment facilities would certainly help and support the liquid waste management of Barangay Poblacion that will also ensure clean water environment, and boost its tourism industry and uphold structural integrity of public facilities and utilities of the municipality as a whole; Now, therefore, be it...


