**RESOLUTION NO. 21-12-409**

**RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 03-2021, SUPPLEMENTAL BUDGET NO. 2 FY 2021 OF BARANGAY SAN ROQUE, BULALACAO, ORIENTAL MINDORO ENTITLED "AN ORDINANCE APPROPRIATING THE AMOUNT OF FIVE HUNDRED TEN THOUSAND ONE HUNDRED TWENTY FIVE PESOS AND FIFTY THREE CENTAVOS (PHP510,125.53) TAKEN FROM UNAPPROPRIATED SURPLUS OF CY 2019-2020 OF BARANGAY SAN ROQUE, BULALACAO, ORIENTAL MINDORO" OPERATIVE IN ITS ENTIRETY**

**"WHEREAS**, Section 57 and Section 447 par (li) of RA No. 7160 empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

**"WHEREAS**, the Sangguniang Barangay of San Roque, Bulalacao, Oriental Mindoro submitted its Supplemental Budget No. 2 for FY 2021 showing therein the sources of income and object of expenditures to this Sanggunian for review on December 20, 2021 pursuant to the provisions of Republic Act (R.A.) No. 7160;

**"WHEREAS**, the Supplemental Budget No. 2 for FY 2021 of Barangay San Roque was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on December 27, 2021 and was found to be consistent with pertinent laws, rules and regulations;

**"WHEREAS**, Sangguniang Barangay of San Roque, Bulalacao, Oriental Mindoro is likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the attached review letter which became integral part of this resolution;
