RESOLUTION NO. 21-12-412

RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2 SERIES OF 2020, UNNUMBERED SUPPLEMENTAL BUDGET FY 2021 OF BARANGAY BENLI, BULALACAO, ORIENTAL MINDORO ENTITLED "APPROPRIATING THE AMOUNT OF ONE MILLION THREE HUNDRED FORTY EIGHT THOUSAND NINE HUNDRED FOURTEEN PESOS (PHP1,348,914.00) TAKEN FROM SURPLUS 2015" OPERATIVE IN ITS ENTIRETY

"WHEREAS, Section 57 and Section 447 par (li) of RA No. 7160 empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, the Sangguniang Barangay of Benli, Bulalacao, Oriental Mindoro submitted its Unnumbered Supplemental Budget for FY 2021 showing therein the sources of income and object of expenditures to this Sanggunian for review on December 20, 2021 pursuant to the provisions of Republic Act (R.A.) No. 7160;

"WHEREAS, the Unnumbered Supplemental Budget for FY 2021 of Barangay Benli was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on December 27, 2021 and was found to be consistent with pertinent laws, rules and regulations;

"WHEREAS, Sangguniang Barangay of Benli, Bulalacao, Oriental Mindoro is likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the attached review letter which became integral part of this resolution;

"WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing rules and regulations of Commission on Audit and all other government agencies, Now, therefore, be it
