WHEREAS, the National Irrigation Administration is mandated to investigate, study and develop all available water resources in the country primarily for irrigation purposes. The NIA is task to plan, design, construct and improve all types of irrigation projects and appurtenant structures to operate, maintain and administer all national irrigation system;

WHEREAS, maintenance of irrigation is important to farming activities because irrigation in arid areas provides two essential agricultural requirements; moisture supply for plant growth which also transports essential nutrients and a flow of water to leach or dilute salts in the soil;

WHEREAS, Bulalacao, Oriental Mindoro is a vast agricultural land producing large volume of palay, onions, garlic, corn and peanuts and a wide varieties of fruits and vegetables transported to nearby provinces and Metro Manila;


