EARNESTLY REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS [DPWH] TO ALLOCATE THE NECESSARY FUNDS FOR THE BRIDGE WIDENING PROJECT IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO PARTICULARLY THE WIDENING OF CORING-OT BRIDGE IN SITIO CAWACAT, BARANGAY CAMBUNANG, THIS MUNICIPALITY

“WHEREAS, Coring-ot Bridge in Sitio Cawacat, Barangay Cambunang, Bulalacao, Oriental Mindoro is located along the Strong Republic Nautical Highway and a major thoroughfare of all kinds of vehicles coming from Occidental Mindoro and from Panay Island going to Manila;

“WHEREAS, Coring-ot Bridge was constructed a very long time ago and probably designed to compromise with that of barangay road, that today it needs to be widened to better serve to suit with that of a national highway to cater increasing large and heavy vehicles;


“WHEREAS, it is sadly noted that the national highway along the Coring-ot Bridge is considered as “accident prone area” because of severely vehicle accidents occurred which resulted to the lost of lives and properties;

“WHEREAS, just recently, on that same area, an old man crossing the bridge was hit by an unknown vehicle which caused his untimely death; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED To: Earnestly request the Department of Public Works and Highways [DPWH] to allocate the necessary funds for the bridge widening project in the Municipality of Bulalacao, Province of Oriental Mindoro particularly the widening of Coring-ot Bridge in Sitio Cawacat, Barangay Cambunang, this Municipality;






