REQUESTING THE NATIONAL FOOD AUTHORITY (NFA) ROXAS, ORIENTAL MINDORO TO ESTABLISH AN NFA BUYING STATION IN THE MUNICIPALITY OF BULALACAO, THIS PROVINCE

“WHEREAS, the Municipality of Bulalacao is geographically located in the southernmost tip of the Province of Oriental Mindoro and approximately 45 kms. away from the nearest NFA warehouse in Roxas, Oriental Mindoro;


“WHEREAS, during the harvest season, farmers find difficulties in selling their produce, some are compelled to sell to local traders at a low price because most of them have no means of transporting their harvest to the buying station. Lack of post harvest facilities like the mechanical dryer is another important issue to consider;

“WHEREAS, the establishment of the NFA buying station at this Municipality would definitely provide the farmers with convenience and better choice to sell their harvest at fair price which help them earn more from their harvest; **Now, therefore, be it**


