**EARNESTLY REQUESTING THE HONORABLE ALFONSO V. UMALI, JR., PROVINCIAL GOVERNOR, PROVINCE OF ORIENTAL MINDORO TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF THE REMAINING PORTION OF THE SEA WALL CUM ACCESS ROAD FROM FISH PORT TO RORO PORT SITUATED IN BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO**

**"WHEREAS,** the distance of the access road from the Municipal Fish Landing Port to the RoRo Port is estimated to be one (1) kilometer that half of it was already constructed through the effort and funds from the Provincial Government of Oriental Mindoro;

**"WHEREAS,** the access road mentioned above is included in the Marine Reserved Areas of the municipal government where the Bulalacao Bay Park and Reclamation Site are to be erected in support to the claim of Bulalacao to be the next tourist destination of the province;

**"WHEREAS,** there is a need to complete the construction of the access road from the Municipal Fish Landing Port going to the RoRo Port in order to facilitate the movement of people and shipment of goods and services within the area for the benefits of the passengers and the business sector doing business activities everyday; Now, therefore, be it

Umali, Jr., Provincial Governor, Province of Oriental Mindoro to allocate the necessary funds for the construction of the remaining portion of the access road from Fish Port to RoRo Port situated in Barangay Poblacion, Bulalacao, Oriental Mindoro;






