**RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2016-08-5 OF BARANGAY SAN JUAN, REALIGNING THE AMOUNT OF SIXTY SIX THOUSAND NINE HUNDRED FIFTY TWO PESOS (PHP66,952.00) TAKEN FROM THE HONORARIUM OF SK, CASH GIFT AND HONORARIUM OF BARANGAY POLICE TO AUGMENT FUND FOR PRODUCTIVITY ENHANCEMENT INCENTIVES (PEI)**

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Approve Appropriation Ordinance No. 2016-08-5 of Barangay San Juan, Realigning the amount of Sixty Six Thousand Nine Hundred Fifty Two Pesos (PhP66,952.00) taken from the Honorarium of SK, Cash Gift and Honorarium of Barangay Police to augment fund for Productivity Enhancement Incentives (PEI) with the following recommendation, to wit:


1. That, the granting of PEI shall be in accordance with COA Rules and Regulations;
2. That, provisions of Executive Order No. 201 shall be conformed with accordingly with emphasis on Section 6 which states that PEI shall not be given earlier than December 15 of every year;
3. That, compliance with all existing and applicable laws, rules and regulations shall be the sole responsibility of the Sangguniang Barangay of San Juan in connection with the implementation of said appropriation ordinance.


