RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 1 CY 2016 OF BARANGAY MAUJAO AMOUNTING TO ONE HUNDRED TWO THOUSAND SEVEN HUNDRED TWELVE PESOS AND SIXTY FOUR CENTAVOS (PHP102,712.64) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 2016-08 DATED DECEMBER 6, 2016

RESOLVED AS IT IS HEREBY RESOLVED To: Approve Supplemental Budget No. 1 CY 2016 of Barangay Maujao amounting to One Hundred Two Thousand Seven Hundred Twelve Pesos and Sixty Four Centavos (PhP102,712.64) with the following recommendations, to wit:

1. That, the procurement of supplies and materials is in accordance with RA 9184 (Government Procurement Reform Act);
2. That, the disbursement of fund shall be in accordance with COA Rules and Regulations;

4. That, compliance with all existing and applicable laws, rules and regulations shall be the sole responsibility of the Sangguniang Barangay of Maujao in connection with the implementation of said appropriation ordinance.


