RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 01, SERIES OF 2020 OF BARANGAY MILAGROSA, BULALACAO, ORIENTAL MINDORO ENTITLED "APPROPRIATING THE AMOUNT OF THIRTY THOUSAND PESOS (PHP30,000.00) TAKEN FROM 20% DEVELOPMENT FUND 2019 (DUMPING SITE) TO AUGMENT FUND FOR REHABILITATION OF BENCHING OF BARANGAY PLAZA OF BARANGAY MILAGROSA, BULALACAO, ORIENTAL MINDORO" OPERATIVE IN ITS ENTIRETY

"WHEREAS, Section 57 and Section 447 par (li) of RA No. 7160 empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, Appropriation Ordinance No. 01 series of 2020 of Barangay Milagrosa, Bulalacao, Oriental Mindoro entitled "Appropriating the amount of thirty thousand pesos (PhP30,000.00) taken from 20% Development Fund 2019 (Dumping Site) to augment fund for Rehabilitation of Benching of Barangay Plaza of Barangay Milagrosa, Bulalacao, Oriental Mindoro" was submitted to this Sanggunian for review on March 13, 2020 pursuant to the provisions of Republic Act (R.A.) No. 7160;






