EARNESTLY REQUESTING HIS EXCELLENCY BENIGNO SIMEON C. AQUINO, III, PRESIDENT, REPUBLIC OF THE PHILIPPINES THRU THE HONORABLE ALFONSO V. UMALI, JR., PROVINCIAL GOVERNOR, PROVINCE OF ORIENTAL MINDORO TO INCLUDE IN HIS PRIORITY BILL THE LAW GRANTING FREE SOCIAL AND HEALTH INSURANCE COVERAGE TO BARANGAY OFFICIALS AND VOLUNTEER WORKERS

"WHEREAS, barangay officials and volunteer workers deliver necessary services and are regarded as the first responders of the government in times of crisis and disputes in their localities so that there is a need to ensure the health benefits due to them in order to make them an active partner in the delivery of social services down to the far-flung barangays;

"WHEREAS, barangay officials and volunteer workers work jointly to address the needs of the residents even during night time, spending long hours of indefinite services, and sometimes face with danger as they carry out their task, that it is just proper to give them social and health benefits to compensate to all their sacrifices and hardwork;


