RESOLUTION REQUESTING FATIMA UNIVERSITY MEDICAL CENTER TO TIE UP WITH THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO REGARDING THE DEPLOYMENT OF SEVERAL HEALTH PERSONNEL TO THE BULALACAO COMMUNITY HOSPITAL LOCATED IN BULALACAO, ORIENTAL MINDORO

“WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.

“WHEREAS, the University of Santo Tomas Hospital holds in highest esteem the core values of competence, commitment and compassion in the healthcare profession and service, nourished and tempered by truth and justice understood and taught within the Catholic and Dominican tradition. The hospital has two divisions, a clinical teaching hospital that offers inexpensive medical care for indigent patients and a private hospital for patients with financial means, which is partially used to subsidize the clinical division;

“WHEREAS, Bulalacao, a third class municipality located at the southernmost tip of the Province of Oriental Mindoro with a total population of 39,107 based on 2015 census, 25 percent of which are indigenous people called Hanunuo Mangyan, has a municipal government that uplifts the general health condition of its people;

"WHEREAS, Bulalacao is the farthest municipality from the City proper which is the Calapan City, it is unfortunate that in times of emergencies where matters between life and death is concern, the ailing patients of this municipality need to have a long travel just to sustain their immediate medical attention;

"WHEREAS, the deployment of several health personnel in the Bulalacao Community Hospital would cater more Bulalacaonons in giving quick and efficient medical services, it would also provide the opportunity to have additional medical equipment that would be beneficial and can accommodate different medical needs to them;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, To; request the Fatima University Medical Center to tie up with the Local Government Unit of Bulalacao, Oriental Mindoro regarding the deployment of several health personnel to the Bulalacao Community Hospital located in Bulalacao, Oriental Mindoro.
