### RESOLUTION NO. 20-03-245

**EARNESTLY REQUESTING THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) THRU SECRETARY EDUARDO M. AÑO TO KINDLY FACILITATE THAT EXPENSES INCURRED DURING THE IMPLEMENTATION OF ENHANCED COMMUNITY QUARANTINE DUE TO COVID-19 IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO BE REPLENISHED FOR THE CONTINUOUS IMPLEMENTATION OF VARIOUS PROGRAMS AND PROJECTS POSTPONED TO PRIORITIZE THE DELIVERY OF BASIC SOCIAL SERVICES TO THE AFFECTED RESIDENTS**

“WHEREAS, the onslaught of typhoons such as Tisoy on December 3, 2019 and super typhoon Ursula on December 25, 2019 brought remarkable losses in agriculture, livestock and fishing industries including infrastructural facilities such as roads and bridges, school buildings, hospital and destruction of residential areas that reached to 90%, all these resulted to a feelings of deep grief and misfortune among the inhabitants;

“WHEREAS, in less than three (3) months, the outbreak of Corona Virus Disease 2019 (COVID-19) constitute an emergency that threatens national security so that all government agencies including local government units are enjoined to immediately act to prevent loss of precious human lives, therefore, LGU should utilize appropriate resources to implement urgent and critical measures to prevent the spread of Covid-19, mitigate its effects and impact to the community and prevent serious disruption of the functioning of the government and the community;

**"WHEREAS**, the Municipality of Bulalacao, Province of Oriental Mindoro is a Pro-Poor Municipality pursuant to Executive Order No. 370 whose resources depends mainly from Internal Revenue Allotment distributed a priority programs and projects however, because of havoc such as Typhoons Tisoy and Ursula and Covid-19 caused financial drain to the detriment of the delivery of basic social services leaving us the only hope that the national government could replenish the funds; **Now, therefore, be it**


**RESOLVED AS IT IS HEREBY RESOLVED, To:** Earnestly request the Department of the Interior and Local Government (DILG) thru Secretary Eduardo M. Año to kindly facilitate that expenses incurred during the implementation of Enhanced Community Quarantine due to COVID-19 in the Municipality of Bulalacao, Province of Oriental Mindoro be replenished for the continuous implementation of various programs and projects postponed to prioritize the delivery of basic social services to the affected residents;


