PARAGAS, CHIEF OPERATING OFFICER TO ALLOCATE TWENTY MILLION PESOS (PHP20M) TO BE USED FOR THE INSTALLATION OF SOLAR STREETLIGHTS FROM THE NATIONAL HIGHWAY, CAWACAT JUNCTION TO BARANGAY BALATASAN, BULALACAO, ORIENTAL MINDORO**




