RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO REPRESENT THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO TO ENTER INTO MEMORANDUM OF AGREEMENT WITH MINDORO STATE COLLEGE OF AGRICULTURE AND TECHNOLOGY (MinSCAT) REPRESENTED BY ITS PRESIDENT, MR. JESSE T. ZAMORA FOR THE ESTABLISHMENT OF MinSCAT BONGABONG CAMPUS, BULALACAO EXTENSION CLASS INCLUDING ALL RELATED POLICIES AND GUIDELINES THAT MAY BE AGREED UPON BY BOTH PARTIES
