RESOLUTION SIGNIFYING OPPOSITION AND OBJECTION TO THE STATEMENT RAISED BY COL. RENWICK K. RUTAQUIO, PA (RET.), REGIONAL DIRECTOR, LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD (LTFRB), REGIONAL OFFICE, LIPA CITY, BATANGAS IN HIS LETTER TO THE SANGGUNIANG BAYAN OF BULALACAO, PROVINCE OF ORIENTAL MINDORO DATED DECEMBER 10, 2018

“WHEREAS, on April 6, 2018, the Sangguniang Bayan of Bulalacao, Oriental Mindoro passed Resolution No. 18-04-056 entitled “Earnestly requesting President Roa Duterte, Republic of the Philippines to kindly instruct the Land Transportation Franchising and Regulatory Board (LTFRB) to take immediate action on applications for franchise of vans operating within the Provinces of Oriental and Occidental Mindoro” in response to the clamor of the riding public suffering difficulties and inconvenience in transportation because of limited vans and buses allowed to operate;

“WHEREAS, it was learned that amidst the transportation crisis in Mindoro Provinces that times there were pending franchise applications before LTFRB such that taking immediate attention on such applications would have lessened the burden of helpless riding public;

“WHEREAS, it is well understood that the LTFRB like any other government agency needs to implement policies, laws and regulations to ensure the safety and welfare of the people and it must be noted that this Sangguniang Bayan through Resolution No. 18-04-056 was asking for immediate action for applications-action may be disapproved or approved dependent on the merit of the application and the submitted requirements;









