RAPAL ENGAGING THE SERVICES OF THE LATTER AS ENGINEERING ASSISTANT DETAILED IN THE MUNICIPAL ENGINEERING OFFICE STARTING FROM JANUARY 16, 2020 UNTIL DECEMBER 31, 2020 UNLESS SOONER TERMINATED AND SUCH OTHER TERMS AND CONDITIONS THAT MAY BE AGREED UPON BY BOTH PARTIES
