AUTHORIZING THE MUNICIPAL MAYOR TO EXECUTE ON THE DISPOSITION OF THE LOCAL GOVERNMENT UNIT'S SERVICE FEES RECEIVED FROM THE PHILHEALTH INSURANCE CORPORATION (PHILHEALTH) RELATED TO THEIR FUNCTION AS ACCREDITED COLLECTING AGENT (ACA)

"WHEREAS, on January 2022 the Local Government Unit of Bulalacao became PhilHealth's Accredited Collecting Agent to received payment for PhilHealth Premium Contribution from its members under the Formal Economy and Informal Economy as an additional payment venue to avoid problems on availment of PhilHealth benefits;

"WHEREAS, a Collection and Remittance Agreement (CRA) signed and approved by both PhilHealth and the LGU is the binding documents authorizing the LGU to accept premium payment;

"WHEREAS, stipulated in the Collection and Remittance Agreement (CRA) that PhilHealth shall pay the LGU a corresponding service fee for any collection made in accordance and as authorized by the Department of Finance (DOF);

"WHEREAS, PhilHealth leaves the disposition of the service fees with the Local Government Unit or the Local Chief Executive prioritizing the operational cost and honoraria of the people handling the transactions;

"WHEREAS, after a thorough deliberation, the members of the Honorable Body is of the consensus to appropriate the said matter; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Implement the following disposition allocation of the PhilHealth Service Fees to ensure effective disbursement of fund:

- A. Operational Cost 60%, which include Supplies, Equipment, Internet Connectivity, Travel Expenses, Capability Building of the Finance/Treasurer's Office and Staff;
- B. Honoraria 40% to be distributed as:
 - Municipal Treasurer - 20%
 - Municipal Accountant - 10%
 - Special Collecting Officer - 10%

RESOLVED FURTHER, To: Let copies of this Resolution be furnished the Philippine Health Insurance Corporation through its Chief Social Insurance Officer, Ma. Neresa C. Reganit of the Local Health Insurance Officer-Oriental Mindoro for their information and guidance;
