EARNESTLY REQUESTING THE BUREAU OF FISHERIES AND AQUATIC RESOURCES, REGION IV-B, MIMAROPA TO GRANT THE NECESSARY AMOUNT TO BE USED FOR THE CONSTRUCTION OF FISHING BANCA TO BE DISTRIBUTED TO THE MARGINALIZED FISHERMEN IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO WHO WERE HEAVILY DAMAGED BY SUPER TYPHOON URSULA

WHEREAS, series of typhoon hit the Municipality of Bulalacao, Province of Oriental Mindoro, Typhoon Tisoy on December 3,2019 and on December 25,2019, Christmas Day to be exact, Typhoon Ursula which ruined houses and other building structures, devastated infrastructural facilities and water system supply, shut-down electricity and communication network, and destroyed agriculture, livestock, aquaculture, and fishing industries;

WHEREAS, the Municipal Agriculture Office reported remarkable damages on agriculture, livestock and fishing industry including the damages on fishing banca and fishing gears of marginalized fisherfolks;


WHEREAS, to help fisherfolks recover from their losses on fishing financial assistance from higher government agency such as the Bureau of Fisheries and Aquatic Resources is direly needed to be used for the restoration and rehabilitation of fishing industry in Bulalacao; Now, therefore be it....

RESOLVED AS IT IS HEREBY RESOLVED, TO: Earnestly request the Bureau of Fisheries and Aquatic Resources, Region IV-B, MIMAROPA to grant the necessary amount to be used for the construction of fishing banca to be distributed to the marginalized fishermen in the Municipality of Bulalacao, Oriental Mindoro who were heavily damaged by Super Typhoon Ursula;






