EARNESTLY REQUESTING THE OFFICE OF THE CIVIL DEFENSE (OCD) TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF EVACUATION CENTERS IN MILAGROSA HIGH SCHOOL, BATING ELEMENTARY SCHOOL AND MILAGROSA ELEMENTARY SCHOOL, ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, evacuation centers are to provide safe emergency shelter for a short time before the disaster strikes. In principle, evacuation centers will provide safe shelter to communities at potential risk of disaster;


"WHEREAS, a school multi-purpose building serves as venue for multiple school programs and functional purposes such as the conduct of sports and recreation center which could be both enjoyed by teachers and students even during inclement weather;

"WHEREAS, Milagrosa Elementary and High Schools and Bating Elementary School is in dire need of a multi-purpose cum evacuation building to house various school activities for the social and intellectual benefits of students and teachers; **Now, therefore, be it**


